The Board accredits:

Electrical Power Systems Construction Association

as the bargaining agent for the following bargaining unit of Employers:

all employers employing operating engineers and operating engineer foremen, as defined in the current collective agreement, as it may be amended from time to time, between the Electrical Power Systems Construction Association and the International Union of Operating Engineers, engaged in all construction work* in the electrical power systems sector performed on Ontario Power Generation Inc., Bruce Power LP and Hydro One Networks Inc. property, and property acquired by Ontario Power Generation Inc., Bruce Power LP and Hydro One for (a) the supply of aggregate and concrete used in the construction of said facilities; and (b) ancillary material yards which are defined as property acquired by Ontario Power Generation Inc. (OPGI) and Hydro One for the storage of materials to be used on a project by Employers, in the Province of Ontario for the bulk power system for whom the International Union of Operating Engineers hold bargaining rights in the electrical power systems sector, save and except operating engineers employed by an Employer signatory to the Crane and Equipment Rental Agreement with Local Union 793 when performing work covered by the scope of that agreement.

For the purposes of clarity, the bulk power system comprises: generating stations, hydraulic works, Heavy water facilities in the province of Ontario; and transmission lines (voltages over 50KV), transmission stations, microwave and repeater stations on Ontario Power Generation Inc., Bruce Power LP and/or Hydro One Networks Inc. property, save and except building of commercial office-type facilities at urban locations remote from operating facilities.

* The work encompasses:

- construction of new facilities
- additions to existing facilities
- modifications
- rehabilitation
- reconstruction of existing facilities
