EMPLOYER BARGAINING AGENCY DESIGNATION

In the "painters" Employer Bargaining Agency Designation ("Designation") dated March 29, 1978, the International Brotherhood of Painters and Allied Trades ("the Brotherhood") and the Ontario Council of the International Brotherhood of Painters and Allied Trades ("the Ontario Brotherhood") were cited as affiliated bargaining agents.

Since then, the Brotherhood and the Ontario Brotherhood have changed their names to "the International Union of Painters and Allied Trades" and "the Ontario Council of the International Union of Painters and Allied Trades" respectively. Thus, it has become necessary to replace the Designation.

THEREFORE, pursuant to my authority under subsection 153(5) of the *Labour Relations Act, 1995*, I hereby revoke the above-mentioned Designation, and substitute the following Designation:

Pursuant to clause 153(1)(b) of the *Labour Relations Act, 1995*, I hereby designate a Council of employers' associations consisting of,

- (a) the Ontario Painting Contractors Association;
- (b) the Interior Systems Contractors Association of Ontario; and
- (c) the Acoustical Association of Ontario,

as the employer bargaining agency to represent in bargaining in the industrial, commercial and institutional ("ICI") sector of the construction industry in Ontario all employers whose employees are represented by,


- (d) the International Union of Painters and Allied Trades and the Ontario Council of the International Union of Painters and Allied Trades; or
- (e) Local Unions 114, 200, 205, 557, 864, 1003, 1080, 1494, 1590, 1671, 1783, 1824, 1832, 1891, 1904, 1919; or
- (f) any other Local of the International Union of Painters and Allied Trades which in the future may be chartered to represent painters, employees engaged in the laying of resilient tiles, ceramic tiles, hardwood tiles, sheet goods, linoleum or carpets, or drywall tapers, plasterers or fireproofing applicators,

(hereinafter collectively referred to as "the Unions") and all employers bound by or parties to,

- (g) a certificate of the Ontario Labour Relations Board granted to the Unions or any of them;
- (h) a voluntary recognition agreement with the Unions or any of them; or
- (i) a collective agreement to which the Unions or any of them have been or are party to or bound by,

covering the ICI sector of the construction industry in Ontario.
