EMPLOYER BARGAINING AGENCY DESIGNATION

Pursuant to subsection 5 of section 153 of the Labour Relations Act, 1995, the designation of the United Brotherhood of Carpenters and Joiners of America and the Ontario Provincial Council of the United Brotherhood of Carpenters and Joiners of America dated March 3, 1978 and amended April 10, 1980, is further amended by replacing the list of affiliated bargaining agents found in items one through four of paragraph two with the following paragraph:

- 1. United Brotherhood of Carpenters and Joiners of America; or
- 2. Carpenters' District Council of Ontario, United Brotherhood of Carpenters and Joiners of America; or
 - (1) The Ontario Provincial Council of Ontario, United Brotherhood of Carpenters and Joiners of America, or the
 - (2) The Carpenters' District Council of Toronto and Vicinity, or the
 - (3) Lake Ontario District Council, or the
 - (4) Western Ontario District Council, or the
 - (5) Ontario Acoustical and Drywall District Council; or
- the following Local Unions: 18, 27, 93, 249, 397, 446, 494, 572, 675, 785, 1071, 1256, 1450, 1669, 1946, 1988, 2041, 2050, 2222, 2451, 2486 of the United Brotherhood of Carpenters and Joiners of America or their predecessors; or
- 4. any other Local of the United Brotherhood of Carpenters and Joiners of America which in the future may be chartered to represent Journeymen and Apprentice Carpenters other than Millwrights,

so that the designation reads as follows:

Pursuant to clause <u>b</u> of subsection 1 of section 153 of the *Labour Relations Act, 1995*, I hereby designate the United Brotherhood of Carpenters and Joiners of America Employer Bargaining Agency consisting of Acoustical Association of Ontario, Caulking Contractors Association of Ontario, Labour Relations Bureau of Ontario General Contractors Association, Resilient Flooring Contractors Association of Ontario, Industrial Contractors Association of Canada and the Interior Systems Contractors Association of Ontario as the employer bargaining agency to represent in bargaining all employers whose employees are represented by the following affiliated bargaining agents:

- United Brotherhood of Carpenters and Joiners of America; or 1.
- 2. Carpenters' District Council of Ontario, United Brotherhood of Carpenters and Joiners of America; or
 - The Ontario Provincial Council of Ontario, United Brotherhood of (1) Carpenters and Joiners of America, or the
 - (2) The Carpenters' District Council of Toronto and Vicinity, or the
 - (3)Lake Ontario District Council, or the
 - (4)Western Ontario District Council, or the
 - (5)Ontario Acoustical and Drywall District Council; or
- 3. the following Local Unions: 18, 27, 93, 249, 397, 446, 494, 572, 675, 785, 1071, 1256, 1450, 1669, 1946, 1988, 2041, 2050, 2222, 2451, 2486 of the United Brotherhood of Carpenters and Joiners of America or their predecessors; or
- 4. any other Local of the United Brotherhood of Carpenters and Joiners of America which in the future may be chartered to represent Journeymen and Apprentice Carpenters other than Millwrights,

(Which Council and Unions are hereinafter collectively referred to as the "Unions"), in the industrial, commercial and institutional sector of the construction industry in the Province of Ontario, and without limiting the generality of the foregoing, bargaining as aforesaid, all employers bound by or parties to:

- (a) certificates of Ontario Labour Relations Board to the Unions or any of them;
- (b) voluntary recognition agreements between the Unions or any of them and any employers;
- (c) collective agreements to which the Unions or any of them or their predecessors have been or are party to or bound by, covering the industrial, commercial and institutional sector of the construction industry in the Province of Ontario.
