EMPLOYER BARGAINING AGENCY DESIGNATION

By a Designation dated March 3, 1978 and amended April 10, 1980 and June 23, 1997, the Labour Relations Bureau of the Ontario General Contractors' Association ("Bureau") was designated as part of the "carpenters" employer bargaining agency to represent in bargaining all employers whose employees are represented by certain affiliated bargaining agents.

Since then, the Bureau has incorporated and changed its name to the "Construction Labour Relations Association of Ontario", so it has become necessary to replace the Designation.

THEREFORE, pursuant to my authority under subsection 153(5) of the Labour Relations Act, 1995, I hereby revoke the abovementioned Designation and its amendments, and substitute the following Designation:

Pursuant to clause 153(1)(b) of the Labour Relations Act, 1995, I hereby designate the United Brotherhood of Carpenters and Joiners of America Employer Bargaining Agency, consisting of,

- (a) the Acoustical Association of Ontario;
- (b) the Caulking Contractors Association of Ontario;
- (c) the Construction Labour Relations Association of Ontario;
- (d) the Resilient Flooring Contractors Association of Ontario;
- (e) the Industrial Contractors Association of Canada; and
- (f) the Interior Systems Contractors Association of Ontario,

as the employer bargaining agency to represent in bargaining in the industrial, commercial and institutional ("ICI") sector of the construction industry in Ontario all employers whose employees are represented by,

- (g) United Brotherhood of Carpenters and Joiners of America; or
- (h) Carpenters' District Council of Ontario, United Brotherhood of Carpenters and Joiners of America; or
 - (i) The Ontario Provincial Council of Ontario, United Brotherhood of Carpenters and Joiners of America, or
 - (ii) The Carpenters' District Council of Toronto and Vicinity, or the
 - (iii) Lake Ontario District Council, or the
 - (iv) Western Ontario District Council, or the
 - (v) Ontario Acoustical and Drywall District Council; or
- (i) Local Unions 18, 27, 93, 249, 397, 446, 494, 572, 675, 785, 1071, 1256, 1450, 1669, 1946, 1988, 2041, 2050, 2222, 2451, 2486 of the United Brotherhood of Carpenters and Joiners of America or their predecessors; or
- (j) any other Local of the United Brotherhood of Carpenters and Joiners of America which in the future may be chartered to represent Journeymen and Apprentice Carpenters other than Millwrights,

(hereinafter collectively referred to as the "Unions") and all employers bound by or parties to,

- (k) a certificate of the Ontario Labour Relations Board to the Unions or any of them;
- a voluntary recognition agreement between the Unions or any of them and any employers; or
- (m) a collective agreement to which the Unions or any of them or their predecessors have been or are party to or bound by,

covering the ICI sector of the construction industry in Ontario.
