EMPLOYEE BARGAINING AGENCY DESIGNATION

By a Designation dated November 13, 2001, the International Brotherhood of Electrical Workers ("IBEW") and the IBEW Construction Council of Ontario were designated as the "electricians" employee bargaining agency to represent employees in bargaining.

Since then, the designated employee bargaining agency has confirmed: that the IBEW Construction Council of Ontario has been granted its charter and has had its bylaws approved by the IBEW; that IBEW Locals 894 and 1739 have ceased to exist; that it would like gender inclusive language to be used in the designations and that updated terms be used to describe trades that are represented by this designation, so it is desirable to update and replace the Designation.

THEREFORE, pursuant to my authority under subsection 153(5) of the *Labour Relations Act, 1995*, I hereby revoke the above-mentioned Designation and substitute the following Designation:

Pursuant to clause 153(1) (a) of the *Labour Relations Act, 1995* ("Act"), I hereby designate the International Brotherhood of Electrical Workers ("IBEW") and the IBEW Construction Council of Ontario as the employee bargaining agency to represent in bargaining in the industrial, commercial and institutional ("ICI") sector of the construction industry all Journeypersons and Apprentice Electricians, Journeypersons and Apprentice Powerline Technicians, Journeypersons and Apprentice Network Cabling Specialists and Communication Cable Installers, represented by the International Brotherhood of Electrical Workers ("IBEW") or the IBEW Construction Council of Ontario or locals 105, 115, 120, 303, 353, 402, 530, 586, 773, 804, or 1687 of the IBEW, or any other local of the IBEW that might be chartered to represent Electricians, Powerline Technicians, Network Cabling Specialists or Communication Cable Installers in the ICI sector of the construction industry.

Pursuant to subsection 153(2) of the *Act*, I hereby exclude from this designation the bargaining relationship between the Quality Control Council of Canada and the Stress Relieving Contractors. This exclusion is subject to the condition that the constitution of the Quality Control Council of Canada is filed together with a copy of the collective agreement affecting these employees.
